ORDINANCE NO. 1-2023

CENTER TOWNSHIP GREENE COUNTY, PENNSYLVANIA

AN ORDINANCE OF CENTER TOWNSHIP, GREENE COUNTY, PENNSYLVANIA, AMENDING ORDINANCE 1-2021 BY AMENDING THE PENALTIES FOR VIOLATIONS AS SET FORTH IN SECTION 8.

WHEREAS, the Board of Supervisors wish to amend the Section 8., Penalties as set forth therein; and

WHEREAS, Center Township is a Township of the Second Class organized and existing pursuant to the provisions of the Second Class Township Code, 53 P.S. § 65101 et. seq. (the "Code"); and

WHEREAS, Center Township wishes to amend its restrictions as to weight limits on its list of roads therein and penalties thereof; and

WHEREAS, Center Township believes it to be in the best interest and welfare of its Township's residents to adopt this Ordinance.

NOW THEREFORE, pursuant to the authority conferred upon it by the Second-Class Township Code as amended, the Township Board of Supervisors of Center Township, Greene County, Pennsylvania, does hereby ENACT AND ORDAIN the following:

SECTION 1: TITLE.

This ordinance shall be known and may be cited as the "Center Township Motor Vehicle Size, Weight and Load Limitations Ordinance of 2023."

SECTION 2: ENACTMENT.

This Ordinance is enacted pursuant to the authority conferred by the Second Class Township Code, as amended and by the "Vehicle Code", Act of 1976, June 17, 162, No. 81, effective July 1, 1977 (75 Pa. C. S.A. 101 et. seq.) as amended.

SECTION 3: DEFINITIONS AND INTERPRETATION.

- A. Words and phrases, when used in this ordinance, except for sections on articles to which different or additional definitions apply, shall have the meanings ascribed to them in the Vehicle Code (the Act of June 17, 1975, P. L. 162 No. 81), as amended, except that, in this ordinance, the word "street" may be used interchangeably with the word "highway", and shall have the same meaning as the word "highway" as defined in the Vehicle Code.
- B. In this ordinance, the singular shall include the plural, the plural shall include the singular, and the masculine shall include the feminine.

SECTION 4: FINDINGS OF THE BOARD OF SUPERVISORS OF THE TOWNSHIP BASED UPON ENGINEER AND TRAFFIC STUDY.

The Board of Supervisors pursuant to an engineering and traffic study have determined and hereby determine that the following roads or bridges under the jurisdiction of the Township may be damaged or destroyed unless the permissible weight of motor vehicles or combinations is reduced to the weight limits listed.

SECTION 5: VEHICLE WEIGHT LIMITS ESTABLISHED ON CERTAIN STREETS AND BRIDGES.

A. On the bridges and streets listed in Section 5 or parts of streets, by authority granted by Section 4902 (a) of the Vehicle Code, as amended, it shall be unlawful for any person or persons to drive any vehicle or combination having a gross weight in excess of the maximum prescribed for that bridge or street or part of street, as the case may be.

- B. The following motor vehicles shall be exempt (as allowed by the relevant statutes and regulations of the Commonwealth of Pennsylvania) from the restrictions imposed under subsection (a) above:
 - 1. School buses;
 - 2. Emergency vehicles;
 - 3. Vehicles making local deliveries of pickups.

SECTION 6: PERMITS AND SECURITY.

The Board of Supervisors of the Township may issue permits for the movement of motor vehicles or combinations of size and weight in excess of the restrictions imposed under Section 6, supra, and require such undertaking or security as the Board of Supervisors deems necessary to

cover the cost of anticipated or probable repairs and/or restoration necessitated by the permitted movement of vehicles.

All actions taken under the authority of this section shall be taken in accordance with the rules and regulations adopted from time to time by the Board of Supervisors and in the absence thereof in accordance with the rules and regulations adopted by the Commonwealth of Pennsylvania, Department of Transportation as found in Title 67 of the Pennsylvania Code.

SECTION 7: ERECTION OF SIGNS.

The Township shall erect or cause to be erected and maintained restriction signs designating the restrictions at each end of a bridge or portion of road restricted as provided in this ordinance. In the case of a restriction on a bridge or on a road which does not begin or end at an intersection with an unrestricted road, the Township shall also place an advance informational sign at the intersection nearest each end of the restricted bridge or portion of road which would allow drivers to avoid the restricted bridge or portion of road. No person shall be convicted of violating any section of this Ordinance unless the restriction sign designating the restricted bridge or portion of road to traffic moving in the direction the person was driving was posted as required in this section. However, failure to post the restriction sign designating the restricted bridge or portion of road to traffic moving in the opposite direction or failure to post any advance informational sign shall not constitute a defense to a violation of this section.

SECTION 8: PENALTIES FOR VIOLATIONS.

The Township reserves the unilateral right to implement any of the options set forth in Section 8 hereof:

- A. Any person operating a motor vehicle or combination upon a road or bridge in violation of a prohibition or restriction imposed under Section 6 is guilty of a summary offense and shall, upon conviction, be sentenced to pay a fine of Seventy Five and 00/100 (\$75.00) Dollars, except that any person convicted of operating a vehicle with a gross weight in excess of a posted weight shall, upon conviction, be sentenced to pay a fine of One Hundred Fifty and 00/100 (\$150.00) Dollars plus One Hundred Fifty and 00/100 (\$150.00) Dollars for each five hundred (500) pounds, or part thereof, in excess of three thousand (3,000) pounds over the maximum allowable weight and costs.
- B. Any person who violates any provision of this Ordinance shall be prosecuted under Sections 4902 (a) and 4902 (g) (1) of the Vehicle Code, and, upon conviction, shall be sentenced to pay a fine of Seventy Five and 00/100 (\$75.00) Dollars, except that any person convicted of operating a vehicle with a gross weight in excess of a posted weight shall, upon conviction, be sentenced to pay a fine of One Hundred Fifty and 00/100 (\$150.00) Dollars plus One Hundred Fifty and 00/100 (\$150.00) Dollars for each five hundred (500) pounds, or part thereof, in excess of three thousand (3,000) pounds over the maximum allowable weight, and costs.
- C. Any person who violates any provisions of this Ordinance shall be prosecuted and upon conviction thereof by summary proceedings, be sentenced to pay a fine of not less than Two Hundred Fifty and 00/100 (\$250.00) Dollars and not more than One Thousand and 00/100 (\$1,000.00) Dollars and associated costs. In the event the fine

and costs are not paid, the person shall be sentenced to serve no more than thirty (30) days in jail.

D. The Township reserves the right through its Board of Supervisors to implement a fine of no less than Two Hundred and Fifty (\$250.00) Dollars and up to One Thousand and 00/100 Dollars for each motor vehicle that fails to comply with the terms and conditions of this Ordinance. The aforesaid may be implemented by the Township by way of a certified letter. If the fine is not paid within ten (10) calendar days of the date of service of the certified letter, then the Township reserves the right to proceed with enforcement through paragraph A and/or B as set forth in this Section.

SECTION 9: SEVERABILITY.

The provisions of this Ordinance are hereby declared servable, and if any of its provisions shall be held to be invalid or unconstitutional, or otherwise void for any reason, such decision shall not affect or impair any of the remaining provisions hereof; it is hereby declared to be the intent of the Township that this Ordinance would have been adopted if such invalid, unconstitutional, or otherwise void provision had not been included herein.

SECTION 10: REPEALER.

Any Ordinance containing any provision inconsistent herewith to the extent that such provisions are inconsistent, those provisions are also hereby repealed.

SECTION 11: EFFECTIVE DATE.

This Ordinance shall become effective five (5) days after enactment.
